his new book, "The Ghost of Tom Joad", on Friday,
May 16, at 7:30PM. And while I'm at it, I can't help
but point out our visit on May 3 from longtime member and ally David Rothauser, who will talk about and
show us his new film, "Hibakusha, Our Life to Live".
And on May 25 we have a special Poetry Sunday with

radical poet Richard Cambridge, reading from his novel-in-progress, "1970", an alternate history of that year in which a band of activists led by the Black Panthers bring revolution to the U.S.

We hope you can also join us on Monday May 19, at 7PM, when we will have a conversation with representatives from the Unitarian Universalist Association. Our association and affiliation with the UUA goes back to our founding by Rev. Clarence Skinner, a Universalist minister and Dean of the Tufts University School of Religion. We have always proudly called ourselves non-sectarian and non-creedal. We have had our differences with the UUA, but in the end we have associated with the UUA in many ways, have had several UU ministers both permanent and interim, and have relied on the UUA for guidelines on congregational formation and nurture, and for guidance on leadership and governance. Join us as we welcome the Mass Bay UUA District's Rev. John Millspaugh, and two other UUA folks called "Transition Partners" designated to point us in a strong direction during these interesting and hopeful CCB times.

## Minutes of CCB Board Meeting

Monday April 28, 2014

<u>Various Concerns:</u> A proposed motion to appoint Betsy Gynn to replace Virginia Pratt as CCB's Treasurer (interim) was passed unanimously by the board.

The Board passed, by unanimous vote, a proposal to renew the existing tenant leases for another year.

The annual overage check was received from the restaurant, in excess of the 2013 amount.

A discussion was held on where to store the CCB archives.

<u>Building Concerns:</u> The Board voted to allocate \$1200 for electrical work, concerning the relocation of sprinkler system sensors in the Cave.

Prism Energy Services, a non-profit that works with the utility companies, made proposals to 1) upgrade the track lighting in the Auditorium from incandescent to LED bulbs, and to improve the lighting fixtures on the upper office floors. The Board unanimously approved to spend \$1057 on these energy efficiency measures, which will pay for themselves in less than two years. The utility pays for 70% of the cost of these improvements.

A \$2000 request for the Prison Membership Committee will be postponed/tabled, pending further information.

# An Evening with Peter Van Buren: Ghosts of Tom Joad in Today's Great Recession


Mr. Van Buren, who spent more than two decades working as a foreign-service officer in the U.S. State Department, is a prolific author, as well as coproducer of the new documentary, "Silenced." He will lead a lively discussion of his most recent book, *Ghosts of Tom Joad: A Story of the #99Percent*, an exploration of the causes and effects of ever-deepening economic inequality in America and how average people are getting by in today's downsized, outsourced, and minimum-wage economy.

Tom Joad was the central character of John Steinbeck's *The Grapes of Wrath*, the Depression-era classic, published 75 years ago this month. Many of the economic hardships faced by the fictional Joad family then--increased mechanization of work, home foreclosures, soup kitchens, joblessness--are similar to those faced by "the 99 percent" today and explored in Peter's book.

Ghosts tells the story of radical changes in the American "way of life" through the experiences of a single family, living in a town whose factory has closed. It is based in fact, but told through fiction. (Similarly, Grapes told the story of the fictional Joad family, forced to move from what had been a thriving

farming area and to seek jobs, dignity, and hope elsewhere).

Mr. Van Buren will also be accepting CCB's 2014 Sacco-Vanzetti Award for Social Justice on Sunday, May 18, as a whistleblower himself and on behalf of all whistleblowers. His last book, We Meant Well: How I Helped Lose the Battle for



the Hearts and Minds of the Iraqi People, is an honest examination of often-misguided U.S. "reconstruction" priorities and efforts in post-war Iraq. That book brought him a Kirkus Reviews Best Nonfiction award; but it also drew the attention and ire of the State Department, and of an administration with an unprecedented record of prosecuting whistleblowers, instead of rewarding them for telling the truth. Falsely charged with revealing classified information without government authorization via We Meant Well, Peter became entrapped in a long legal battle that ultimately cost him his government career, fortunately, not his freedom.

Copies of *Ghosts of Tom Joad* will be available for sale and for signing during both of these events with Peter Van Buren.

### **Boston Strong? Art Exhibition**

During the second half of April, local artists Darrell Ann Gane-McCalla, Shea Justice, Jason Pramas had a pop-art exhibition on display at the Community Church of Boston entitled *Boston Strong?* 

The purpose of the show was to spark public discussion and debate about the meaning of the popular "Boston Strong" slogan, and bring light to the disparity between media coverage of the victims of last year's tragic Boston Marathon bombing (many of

whom are white and live outside Boston) and media coverage of the victims of ongoing criminal assaults around Boston -- many of whom are people of color and live in the city.
