"COINTELPRO 2.0: The FBI's Targeting of Black Leadership"

Rev. Bill Alberts, past CCB minister wrote, "The Federal Bureau of Investigation pays a black man (Ronald Wilburn) \$30,000 to offer a bribe of \$1,000 to a black Boston City Councilor (Chuck Turner). What's wrong with this picture?" We will discuss the role of the FBI in the political attacks in Boston within the larger framework of an FBI program to harass communities of color across the nation.

Chuck Turner has been a community organizer and civil rights activist in Boston, Massachusetts since 1966. Referred to as one of the best-known agitators in the city, he was elected to the Boston City Council in 1999.

January 23rd -- PAUL BARAN
"Re-Engaging the Muslim World: An Obama Foreign Policy Doctrine?"

Paul Baran is director of the Outreach Center at the Center for Middle Eastern Studies at Harvard Univ. He teaches "Introduction to the Conflict in Israel and the Occupied Territories", a government course, and directs the Egypt Forum, a program of training for K-12 educators on Middle East regional studies.

Paul regularly writes and speaks on topics related to civil society in the Middle East and the West, Middle East politics, regional human rights and development, & U.S. foreign policy.

January 30th -- GEORGE LEE
"Youth Violence in Boston: Organizing for Survival"

George Lee is a youth worker and community organizer in Boston. He supports youth who are deeply impacted by oppression -- poverty, prisons, broken schools, and violence -- through outreach work, leadership development, and campaigns to change policy and build community power.

George will discuss the root causes of violence and how they play out in the real, everyday lives of young people. He will describe how systems and power brokers have turned their backs on young people, and he will share ways that adult allies can support the struggles of young people to survive and organize.

CCB Board Meeting

*The Board of Directors met on December 14, 2010
Following are highlights of the meeting.*

Financial Report: The treasurer presented a Spending vs. Budget report through November 10, 2010. The amount of \$152,000 was budgeted, resulting in a \$13,000 over budget which is why cuts in staff time were instituted. It was also recommended that a programmed thermostat be installed in order to

reduce heating costs which vary from \$1,100 to \$1,400 monthly with a discount.

Income vs. spending concerning renovations, at this point, are a negative \$500 to \$600 monthly. More money is needed to proceed with building repairs. Expenses are anticipated to be \$75,000 for the next stage of the building renovation.

Building Concerns: A detailed two-hour report was presented by Henry Putman, the reconstruction coordinator, who began by giving an account of the pipe bursting in December, 2009. The architectural plan requires two rated means of egress; we can get away with having one of them. Additional work is needed on exits leading to the fire escape. The fire alarm has been replaced to make it compatible with the required sprinkler system; it is now up to code and modern technological standards.

One-hundred thousand dollars is being received from the insurance companies to meet code compliance for life safety.

It will cover the entirety of the life safety work. The Church still needs an additional \$100,000 immediately to complete the repairs. Plumbing work and remediation has begun to prevent a similar incident to reoccur in the future.

The board expressed its profound gratitude to Henry Putman for the countless hours of his time and expertise.

Various Concerns: The minister’s workdays are Sunday, Tuesday and Wednesday. He will not be accepting telephone calls on other days except those involving pastoral emergencies. He urged everyone to be aware of the needs of the elderly members of the Church.

Heartfelt condolences to Dian & Marty Lerman on the recent passing of Dian’s mother, Ms. Alice Jaffe, in Woodstock, NY.

CCB conveys to all its congregants, friends and to their families, a healthy and peaceful New Year, 2011!

The next meeting of the board is scheduled for Tuesday, January 11, 2011 at 7:15pm. Members and friends of the Church are invited to attend.

Help End the Inhumane Treatment of Bradley Manning!

The Marine Brig at Quantico, Virginia is using “injury prevention” as a vehicle to inflict extreme pre-trial punishment on accused Wikileaks whistleblower Army PFC Bradley Manning. These “maximum conditions” are not unheard-of during an inmate’s first week at a military confinement facility, but when applied continuously for months and with no end in sight they amount to a form of torture. Bradley, who just turned 23-years-old last week, has been held in solitary confinement since his arrest in late May. We’re now turning to Bradley’s supporters worldwide to directly protest, and help bring a halt to, the extremely punitive conditions of Bradley’s pre-trial detention.

We need your help in pressing the following demands: End the inhumane, degrading conditions of pre-trial confinement and respect Bradley’s human rights. Specifically, lift the “Prevention of Injury (POI) watch order”. This would allow Bradley meaningful

physical exercise, uninterrupted sleep during the night, and a release from isolation. We are not asking for “special treatment”. In fact, we are demanding an immediate end to the special treatment.

Please contact these Marine Corps officers and respectfully, but firmly, ask that they lift the extreme pre-trial confinement conditions against Army PFC Bradley Manning:

Further Updates on the CCB Building

We are poised to start work on the 1) sprinkler system installation and 2) the stairwell fireproofing. This will be a difficult and disruptive time, for us and for our guests and our tenants. It involves noise, dust, debris, workers in and out of the building. We apologize in advance for this temporary inconvenience, that will get us to our goal: a renewed, upgraded, safe, up-to-code space.

We will also be working on the auditorium renovations, improvement of our third floor fire egress (through the window and out across the roof). If we can afford it, we will remodel and expand the third floor bathroom for wheelchair access.

We have partial funding for all of this from Church Mutual, our insurance company. We will also be needing additional funds, either from our endowment (AKA the Pax Funds), or from a construction

loan from the Unitarian Universalist Association, or some combination of these two sources. Whatever bold and inventive fundraising we are able to do will allow us to come out of this in better financial shape. There will be a January 9 meeting after lunch, to discuss a funding plan, and to ask the congregation to vote on a resolution. I will not be at this meeting, as I am leading a delegation to El Salvador. I hope that we can reach a consensus about how we are going to finance this important work.

We are at the first anniversary of the flood. I call it CCB's Perfect Storm. We will come away from this stronger, better prepared for the next hundred year event. I sincerely hope that 2011 will see us in our restored Lothrop Auditorium. Enormous thanks go out to Henry Putman, for his valiant efforts in helping us navigate these complicated waters.
