November 2nd -- To Vote, or Not To Vote? (part 2)

"Discrediting Representative Government, Fostering Direct Democracy"

Over and over again elections are stolen by those in power and "the people" are unable to rise up and demand accountability. With each bill, act, and executive order that gets passed we watch our ability to control our lives disintegrate. In a global context the G8, WTO, IMF, and others have more control over our lives as those in elected power represent the interests of government. James will look at a broad historical and global perspective to remind us that, "voting just encourages them."

James Herod is a long-time activist/organizer in anarchist communities and author of *Getting Free: Creating an Association of Democratic Autonomous Neighborhoods* as well as a number of other papers on anarchist praxis.

"The \$700 Billion Question: What is Going on with the Economy?"

Over the past 45 days the stock market has plummeted, gone back up, gone down, and so on. The U.S. government bought approximately \$250 billion in bank shares (with no voting power). Homes are being foreclosed on. What is going on with our economy? The talk will focus on the political economy of the financial crisis, how the Fed and the Treasury bailout package could work, and the implications for those of us without gigantic asset portfolios.

Political Action Doesn't Stop at the Ballot Box

Dear friends and members... Clergy people and religious leadership around the country will use their November newsletters and Sunday sermons to encourage their congregation, mosque, or temple to "vote their values." The conservative and fundamentalist clergy will pretend not to be endorsing McCain as they tell their membership that if they vote for a pro-choice candidate then they are going to Hell or cannot partake in sacraments. Liberal, progressive, and mainstream clergy will pretend not to be endorsing Obama when they tell their membership to vote for an end to the war in Iraq and for the candidate who will bring the responsible change our country needs. Technically clergy and religious non-profits are not allowed to endorse candidates or preach in favor of particular candidates from the pulpit. However, we should not be so naive as to believe that these endorsements are not happening each Sunday and with each newsletter. There are some things I can promise we will talk about as a congregation. We have talked about the impacts racism and White dominant culture has on this election. We have talked about the detriments of the two party system. We use each Sunday to tell stories about those seeking justice around the world. We certainly talk about the impacts militarism has on our country and in worldwide imperialism. One thing I can assure you is that you will not receive candidate endorsements from your congregational director.

With that understanding I am using my role as a Unitarian Universalist/secular/humanist leader to celebrate those in our larger community who understand that voting and electoral politics are not enough. We will spend the last Sunday of October and the first Sunday of November looking at the strategy of voting;

is it a strategic option for bringing about change or is it just distracting us from the possibilities of true communal/global transformation? Regardless of how one feels about the strategy of voting I believe this congregation understands that our political action cannot end at the ballot box. If we wish to live our faith in justice then there is always more that we can do.

Our Board of Directors and Officers recently voted in favor of joining the new sanctuary movement. We were a sanctuary congregation in the 1980's and provided space for a man in need of refuge from Guatemala and then in need of protection from the U.S. government's attempts to deport him back to Guatemala. As we continue to understand the impacts of neo-liberalism and the rights of corporations to move feely across borders through the avenues of free trade we must also hear the stories of those who are forced to leave their homes because of governmental and economic exploitation. Taking a stand against the brutality of the Immigration Customs Enforcement (ICE) must be accompanied with a commitment to end corporate greed and colonization through globalization and "structural adjustment" policies. As a sanctuary congregation we join the Arlington Street Church as the only other church in Massachusetts part of this rebirth of a movement. Thus, along with the many other justice issues you find yourself involved in we are going to need members and friends to stand up and help our commitment as a sanctuary congregation be more than a signature on paper. Please be sure to let me know if you want to get involved. Our potential as a community is bountiful, let us find our greatest potential.

p.s. For those of you who are curious, yes, I do vote.

CCB Board Meeting

The Board of Directors met on October 16, 2008.

Following are highlights of the meeting.

The following board members and guests were present: David Broeg, Jim Casteris, Dick Keshishian, Jason Lydon, John MacLeod, Virginia Pratt, Lenny Shames and Ruediger Volk

Financial Matters: The board has approved a monetary withdrawal from the PAX funds in order to meet the payroll and other expenses. The board has also voted to apply funds for the repair of the CCB roof. Two companies have been consulted and their respective cost estimates are due shortly.

Building Concerns: The Building Committee has recommended retaining the services of Eagle Elevator Company since they were the initial installers of the elevator and are perhaps more knowledgeable about its workings.

Congregational Director's Report: CCB will be connecting with City Life, an organization that aids those in foreclosure procedures, as well as protecting the rights of tenants, to appeal to Sheriff Andrea Cabral to prevent people from being evicted from their homes.



The congregation will express its views on a proposal entitled New Sanctuary Movement put forth by the Unitarian-Universalist Association of Congregations, which, in part, urges the public “to take a moral stand for immigrant rights and to protect immigrants against hate, workplace discrimination and unjust deportation”.

Various Concerns: Ruediger has withdrawn his resignation and has rejoined the board.

At the conclusion of the meeting Virginia, who works as a foreclosure prevention counselor, presented a lengthy and concise analysis of the present foreclosure situation in the Greater Boston area.

The next meeting of the board will be on Thursday, November 20, 2008 at 7:15pm, to which CCB members and friends are invited to attend.

Question 1: Why Vote 'No' to the Income Tax Proposal?

The income tax question on the ballot this fall is a reckless proposal that will have severe and immediate consequences for all of us. This binding referendum will take more than \$12 billion—nearly 40 percent—out of the state budget, driving up local property taxes and leading to drastic cuts in services. Our communities will suffer sweeping education cuts, steep reductions in public safety personnel and further deterioration of roads and bridges.

Here is what we know

- * The income tax proposal will cost the Commonwealth more than \$12 billion in revenues
- * That's 40 percent of the state budget
- * This is a binding proposal that will become law effective January 1, 2009

This reckless proposal will:

- * Drive up local property taxes
- * Have dire consequences for our communities, putting education, health care, public safety, and our state infrastructure at risk.

What to do about it

1. Pledge to VOTE NO
2. Sign up for email from VoteNoMA.com to stay informed. You can do that here. As volunteer opportunities arise we will contact you.
3. Tell your friends and family to VOTE NO. Let them know that you think this is a reckless and bad idea. Send them to VoteNoMa.com and ask them to learn more and sign up to help as well.

Times are hard enough. Let's not make them worse.

After searching for quite some time it is a joy to announce that the International Office of the Women's International League for Peace and Freedom will be moving into the 2nd floor office. The incredible work of WILPF parallels the work of the Community Church. They will be an excellent addition to the social justice framework that holds up our building.

Transgender Day of Remembrance

November 20th is recognized throughout the country as the Transgender Day of Remembrance, which honors the memory of those murdered because of anti-transgender violence. The first Transgender Day of Remembrance was a candlelight vigil held in San Francisco in 1999 to commemorate the anniversary of the murder of Rita Hester, a transgender woman from Boston. On Nov. 28, 1998, Hester was stabbed 20 times in her home and died from cardiac arrest as a result of her wounds. Her attackers were never found. Hester's death set off a national reaction amongst activists looking to create an organized response to the troubling trend of violence against transgender people.

On the one-year anniversary of Hester's death, the first Transgender Day of Remembrance was held. In addition to coordinating the vigil, Gwendolyn Ann Smith also launched the Web site "Remembering Our Dead" to recognize those killed by anti-transgender violence. The number of dead honored on the site has since grown to more than 240.
