# "History of Race in Unitarian Universalism: The Good, the Bad and the Ugly"

Unitarian Universalism has struggled since its inception with issues of race. White culture and white power structures have continuously maintained control and dominance within the faith community. Yet a community of resistance has always been around organizing and mobilizing for a different kind of faith community, an authentically anti-racist multicultural faith. We will discuss the roles of organizations of color within UUism as well as tell some of the stories of white anti-racists along with the stories of where we have fallen short as a faith.

Chester has been an active part of the Jubilee anti-racist ministry out of the UUA and worked with youth, young adults, and adults all around the United States in the forward movement of anti-racist organizing.

# "Uncovering Our History: Community Churches in Context"

Understanding where we come from is essential as we consider where we want to go in the future. The Community Church of Boston and the Community Church of New York come out of a century-long tradition inherited from freewheeling radical congregations, including the "Freethinker" congregations of the 1820s and 1830s and the "People's Churches" of the 1880s and 1890. Prior to the Great Depression, American religion could be far more radical at the level of individual congregations than at the level of denominations, we will explore some of the ways the community churches were part of that radicalism and what that means for our next hundred years.

Dan McKanan joined the Harvard Divinity School faculty in July 2008 as Ralph Waldo Emerson Unitarian Universalist Association Senior Lecturer in Divinity. His first book, *Identifying the Image of God: Radical Christians and Nonviolent Power in the Antebellum United States* (2002), explores theological understandings of violence and nonviolence among abolitionists, pacifists, and temperance activists.

It is through our love and care of one another that we begin to build the alternatives that are necessary as we struggle to rid ourselves of all forms of oppression. I hope to see your beautiful faces at church on Sunday mornings this season as we strive to create one of those essential alternatives in our church.

I am sure everyone is wondering about how things are going with our building. After far too much time we have finally been given a building permit by the city and work has begun on numerous aspects of the rebuild. Jim Casteris, Virginia Pratt, John MacLeod, Rodney Burston and Dean Stevens have been working diligently throughout the summer to keep us on track and making good choices for the future of our building. In the months to come you will be seeing fundraisers and calls for your generous support to get our building back in order. It has taken us until now to get a good sense of the total cost of rebuilding and we are going to need to all step up. Our building is a large part of our ministry in the world, many organizations and radical events find their home inside our walls, we must figure out how to keep our space vital and thriving.

As we prepare for our new season there is much going on in the world. President Obama has been trying to deceive us that the occupation of Iraq is ending. Immigration and Customs Enforcement has been rounding people up around the country and right here in Massachusetts. Los Angeles County Jail approved a heat ray gun to shoot at prisoners as a form of discipline. The fifth anniversary of Katrina has come even as the oil from the BP spill continues to spread. Massachusetts has yet another epidemic of prisoner suicide. And yet even with these struggles that we know about, and those that we are yet to learn of, there is incredible resistance and reason for hope. New Orleans community organizing is continuing to grow and resist the racist rebuilding policies. More and more soldiers are refusing to go off in Obama's imperialist wars. # Lynne Stewart's Ordeal: A 30-year Legal Career Vanishes Behind Bars Because She Did Her Job

On July 15 of this year the First Amendment to the Bill of Rights received another sledge hammer blow. Lynne Stewart, requested by her client in prison to issue one press release by which the sheikh could contact his family in Egypt and tell his comrades in Egypt that they should not consult him; they were on their own. He had been sentenced to 100 years for complicity in the first bombing attack of the World Trade Center. The press release was his last chance to tell them they should forget him and his advice. They were on their own.

The press release took place in the Clinton regime and his Attorney General, Janet Reno, decided that Lynne's violation was too trivial to pursue. This changed in the hysteria after 9/11, aided and abetted by Bush and Cheney and the other high officials of his regime. The new Attorney General, John Ashcroft, dug up Lynne's violation of the Special Administrative Measure that all lawyers with clients in prison signed off on. He charged her with "Aiding a Terrorist," asking for 30 years. The jury convicted her and the federal district court judge, John G. Koeltl, in sentencing, praised Lynne for her devotion to helping people and set the sentence at 28 months, with freedom to pursue her appeal.

We became close friends with Lynne and her partner, Ralph Poynter. They attended our anti-war protests in Malone, county seat of Franklin county in New York state, adjoining Quebec's southern line. Lynne's calling that one press release was an act of compassion, at the request of her client, Sheikh Omar Abdul-Rahman, and out of a deep commitment in her lawyerly career of more than 30 years to the down-and-out. Later she

learned that her client-lawyer privileges had been violated. Listeners were following her supposedly protected conversations with her client.

Lynne and Ralph were stalwarts at our anti-war protests; their long experience with people of all sorts was clearly evident. They are NOT terrorists, nor



AIDERS of terrorists. Nothing untoward happened after that one press release.

The Second Circuit denied the appeal and took the unusual step of demanding that the lower court judge extend his original sentence to anywhere from 15 years to 30 years. This was a one hundred percent act of political opportunism. Koetltl caved in, gave

Lynne ten years in prison. It is so blatantly obvious that Ashcroft was intent on terrorizing citizens, especially lawyers who contemplated defending terrorists.

That is the current status of Lynne's ordeal. We await her legal team's decision and then will do everything we can to spread the word.
